a High School Diploma or GED; <u>and</u> Credential from one of the following:

- Child Development Associate (CDA)
- Family Daycare License or Registration
- ICT Academy or DONA Certificate
- Children's Program Administrator Credential
- NYS Infant Toddler Credential

a High School Diploma or GED; and

ten or more years of experience working with children professionally or as an adult trainer in an early childhood or related.
